Innovative curricula to teach traditional subjects. The best practice of multidisciplinary approach leads to qualitative research transforming the institution into a multifarious organization. The syllabi support the idea of multidisciplinary/interdisciplinary study as its students learn traditional subjects like Vyakarana, Veda, Sahitya, Yoga, Darshan, and Jyotisha, etc., in addition to modern subjects like English, Hindi, History, Political Science and Computer Science, etc., in UG programs.

#### **17.Academic bank of credits (ABC):**

Academic Bank of Credits is a novel idea of the UGC in which the credits earned by the students during their learning period are maintained in this virtual/digital storehouse. Helps them execute the process of multiple exits and multiple entries-curriculum design based on innovative and pedagogical approaches for learning materials, assignments assessments, etc.

#### **18.Skill development:**

Professional programs like M.Ed. are conducted as per the guidelines of NCTE. Professional training in developing the finer elements of skill of the students. Language Lab, Computer Lab, and ICT Lab help the students in areas like internship and practical guidance. Tenday spoken Sanskrit camps for students enhance proficiency in spoken and written skills of Sanskrit and in Devanagari script as well. Dhishana Parishad and Vakyartha Sabha conducted for Sanskrit Students, helps students to improve their Sanskrit language skills. Mukta Swadhyaya Peetham (Open and Distance Learning) conducts various programs and helps Sanskrit lovers learn Sanskrit language skills.

**19.**Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

Integrating the Indian Knowledge System into the curricula. Training students through Sanskrit medium in classroom teaching for traditional programs and Devanagari script in examinations. Teaches Indian languages and Modern subjects like History and Political Science etc. MOOCs are an important online platform to provide the learning of IKS subjects. Non Formal Education provides the facility of learning the traditional subjects of IKS to propagate the rich Indian culture. Vastu Shastra, Natya Shastra, Yoga, Vedang Jyotish, and Sanskrit Literature are taught. Simple Standard Sanskrit is followed in imparting learning in view of NEP 2020.

#### 20.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):

Programmes like Sammanita Shastri, Acharya, Vidya Varidhi, M.Ed., etc are available. The Diploma courses in Yoga, Literature, Vastu, Sanskrit Agam, Prakrit Agam, and Early Childhood Education and Care are available. The subjects like Veda, Vyakarana, Sahitya, Jyotisha, Darshan, Yoga, and Education are being taught. The various training camps like Spoken Sanskrit Workshop, Dhishana Parishad, and Vakyartha Sabha provide enough opportunities to students.

#### **21.Distance education/online education:**

The University has a separate Centre for Open and Distance Education called Mukta Swadhyaya Peetham through which BA Sanskrit, BA Yogashastra, MA Sanskrit, MA Yogashastra, Diploma in Sanskrit Agam, Diploma and Early Childhood Education and Care, Diploma in Sanskrit Journalism and Mass Communication, Diploma in Yoga Application, Certificate Course in Spoken Sanskrit programmes are taught. Provides Self Learning Materials delineating assignments and assessments etc. Has a number of regional centres for conducting contact classes and disseminating knowledge. MOOCs provide online learning to students in a large variety of subjects/topics.

### 2.2 - Catering to Student Diversity

2.2.1 - The institution assesses the learning levels of the students and organises special Programmes for advanced learners and slow learners

Students are the primary stakeholders of the University. The students enrolled in Ramtek and Waranga Campus, Kavikulguru Kalidas Sanskrit University are of diverse socio-economic backgrounds, the majority, especially from rural areas. Under such conditions, variations in the learning potentials of the students are bound to exist. The University provides counseling regarding admission procedures to students of both campuses. The University identifies the slow, average, and advanced learners and makes efforts to address their specific needs through various types of assessment. Assessment of the Students - Initially for admission to various programs of the university, students are evaluated on their performance in the last examination. After admission, the University organizes and conducts special programs for students like vaidic karmakand, mantrochhar, Diksharambh, etc. which leads to peer understanding & recognition. Similarly, bridge courses are also run to help weaker students strengthen the basics of the subject.

### 2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problemsolving methodologies are used for enhancing learning experiences

The University promotes student student-centric learning process. Innovative teaching practices are implemented as a continuous learning process through the cohesive efforts of faculty members and students. The regulations and curriculum of the university are structured to support the academic environment. Experimental learning, participative learning and problem-solving methodologies are integrated in the overall teaching-learning process. Studentcentric methods for enhancing learning experiences: Experiential learningInternship has been introduced in many subjects such as Jyotish, Yoga, and Education for encouraging experiential learning. Students of the Yoga department take the initiative in creating awareness about yogic practice for society. Students take part in Yoga competitions, workshops of Yogamantra, and meditation for mind, body, and soul etc., Students from the Department of Yoga also organized yoga camps at different places giving them experience and exposure to Sadhakas. Besides lectures and tutorials, students are engaged in fieldwork, internships, seminars, group discussion, etc. All these activities are aimed at experimental learning, participative learning, and collaborative learning in a highly effective manner. Problem-solving methodologies are also used for enhancing learning experiences. In Education, four four-week internship programs are there in the syllabus of M.Ed. Students completed their internship program in the teacher Education Institute.

Highquality audio and video devices are provided to faculty members. CUS understands the needs of class facilities and has a high-quality 1GBPS band with easily accessible internet and the campus is Wi-Fi enabled with seamless internet for all ICT activities. E-Platform is also being used for day to day meetings and non-academic activities. KKSU prides itself on its library resources. The library conducts exhibitions to create awareness among faculty members and students regarding the availability of e-resources. Students too have digital access to thousands of books and journals through the central library facilities. Due to unprecedented conditions created by Corona, it was rather a compulsion for the teachers to learn, adopt, and practice with the ICT-enabled tools. 4.4.2 - There are established systems and procedures for maintaining and utilizing physical, academic and support facilities - laboratory, library, sports complex, computers, classrooms etc.

The University provides an excellent academic environment through buildings constructed with state-of-the-art technologies consisting of energy-efficient, water-conserving, and sustainable building materials. The University is spread over two campuses namely, Nagpur and Ramtek, covering around 10 acres of land at Ramtek and 3 floors at NIT building, Nagpur. The University has a 6 number of buildings, auditoriums, laboratories, sophisticated equipment, computers and ICT facilities, and sports and physical education amenities, which are the backbone of academic activities. Besides, there are 02 hostels both for girls and boys, and a guesthouse for guests/faculty/ staff. There is a dedicated Engineering Section, which oversees periodic maintenance of all buildings, roads, and rainwater and grey-water drainage. The Engineering Section has several experienced civil and electrical engineers and is headed by an officer of the Deputy Engineer rank. This section carries out the painting of buildings at regular intervals apart from civil repairs and other maintenance as per necessary or on request. There are a number of roads connecting University gates to academic buildings, administrative buildings, sports grounds, hostels, and a Library on the main campus.

Internal Audit The University has a mechanism for its internal and external financial audits. Internal audit is an ongoing continuous process inaddition to the external auditors to verify and certify the entire Income and Expenditure and the Capital Expenditure of the University each year. Auditors from Local Audit, and staff under them do a thorough check and verification of all vouchers of the transactions that are carried out in each financial year towards internal audit. External Audit In the same manner, an external audit is also carried out in an elaborate way by Principal Auditor General, Govt. of Maharashtra. A team of 3-4 auditors is sent by Auditor General (AG) every year to verify/check the accounts of some months selected randomly by the team so sent. The University accounts are audited regularly by both internal and external statutory audits.
