While discussion on the workshop to be taken on the UGC'S new norms 2018-19 regarding API, it was decided that for the period from 2016 to 2018-19 ( i.e. till the implementation of 7<sup>th</sup> pay commission) the UGC guidelines of 2016 for API Should be implemented.

**Item – 4 To discuss regarding submission of pending AQAR**

It was decided that all the Departments to be informed to submit the Departmental AQAR of 2016-17 and 2017-18 upto the 30 October 2018.

Item - 5 Revised guidelines for preparation for AQAR from the academic year 2018-19

It was decided that Academic year 2018-19 onwards, the AQAR in revised format will be submitted.

Item - 6 Academic Audit of University Departments

All Academic Departments will be informed by Director for BPD to take the action mentioned in the report.

Item - 7 Whether to consider Prak-Shastri teaching work load for Direct Teaching (Category-I A)

Item - 8 Whether Internal Assessment is to be treated as part of assigned teaching duty or should be considered separately in the proforma (Category-I B)

Item - 9 Number of hours to be counted for working in various committees like convocation committee (Category -II B ii)

Item - 10 Number of hours to be allotted for A. Question Paper Setting, Moderation  
B. Invigilation C. Evaluation (Category -I B)

Item - 11 Whether advantageous claim under seminar attendance and/or paper presentation should be considered. If yes, number of hours to be given for participation and paper presentation (Category -II C and Category - III E ii)

For the item no.7 to 11 it was decided that number of hours per week should be calculated as 40% for teaching, 30% for universities services and 30% for research in total 40 hrs. per week.


Item - 12 Any other item with the permission of the Chair.

i) Research Paper publications in Research Journals


While taking in to the consideration the score for API under PBAS, it was decided that the publications in the following journals are to be considered.






1. Taking up some more projects.


सभेच्या सदर निर्णयाची व्यवस्थापन परिषदेकडे शिफारस करण्यात यावी असे सभेत ठरले.
